Motion by Ms. Pezza, supported by Ms. Swanson, to use the reallocation of RIGL 16-7-6(f) categorical transportation aid additional funds to offset the cost of field trips and athletic expenses for the Region. Motion passed 8-0-0 In response to a request for a legal opinion on the use of categorical transportation aid, Dr. Barnes read a letter from the Commissioner addressing this issue: "In response to your request for an interpretation of RI GL 16-7-6(f), I am writing to confirm that the "student transportation costs" for regional districts referenced in the statute include regular transportation between school and home, late busses between school and home, busses for field trips, and busses for athletics."

Dr. Barnes explained that historically, the Region received about \$330,000.00 in transportation aid. Several years ago, the Regional districts formed a coalition and repeatedly lobbied the state for additional transportation funds. This year the Region received about \$530,000.00 - approximately \$200,000.00 of additional transportation categorical funds. Historically, these funds have been passed on to the elementary districts.
